





NOTICE OF PUBLIC HEARING

Notice is hereby given that the Town of Minersville, in Beaver County, Utah, will hold a public hearing on Tuesday September 3, 2019 at the Minersville Town Hall, at 60 West Main in Minersville Utah which will begin at 5:00 pm.

The Town proposes to apply for grant and/or loan funding from the Utah Permanent Community Impact Fund Board (CIB) to upgrade the spring and chlorinator, replace remaining cast iron pipe in town, install new 10-inch PRV at 400 South 300 East and upgrade the water line to the Elementary School to achieve the required fire flow.
